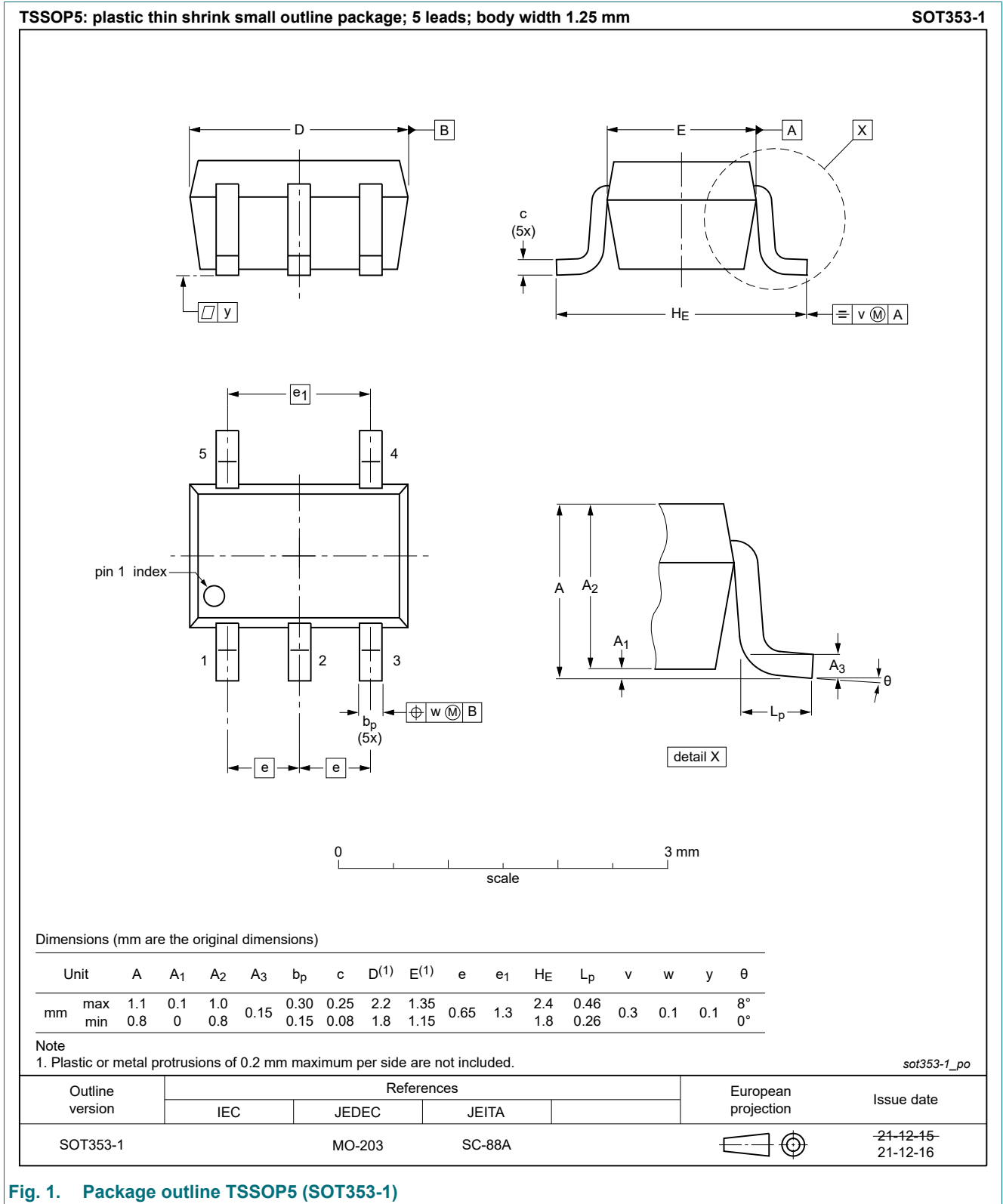

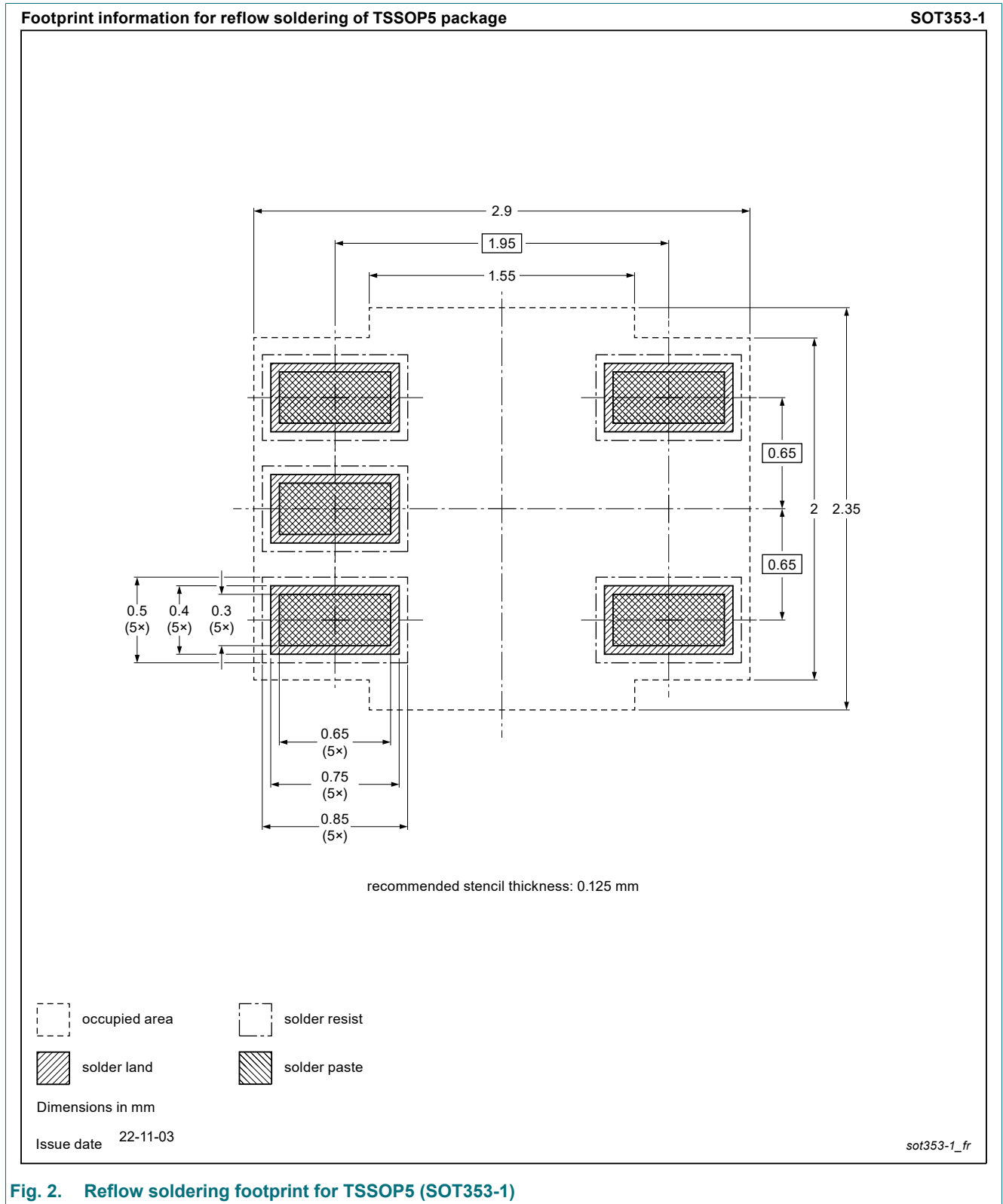


Fig. 2. Reflow soldering footprint for TSSOP5 (SOT353-1)
